- Sub: Scrutinizer's Report on remote e-voting of Postal Ballot conducted pursuant to Section 108 and Section 110 of the Companies Act, 2013 read with rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014.
  - I, Nidhi Bajaj (Proprietor of Nidhi Bajaj & Associates), Practicing Company Secretaries have been appointed as the Scrutinizer by the Board of Directors of KISAN MOULDINGS LIMITED (the Company) for the purpose of scrutinizing
  - i) the remote e-voting under the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015 and Regulation 44 of the SEBI (Listing Obligations and Disclosures Requirements) Regulations 2015;

### 1. MANAGEMENT RESPONSIBILITY

#### 2. SCRUTINISER'S RESPONSIBILITY

My responsibility as Scrutinizer for voting process (i.e. e-voting and physical Postal Ballot Form) is restricted to making a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions contained in the Notice, based on the reports generated from the e-voting system provided by the MUFG; the agency authorised under the Rules and engaged by the Company to provide e-voting facility and attendant papers / documents furnished to me electronically by the Company and /or MUFG for my verification.

3. The Company had appointed M/s. MUFG Intime India Private Limited (MUFG) as the service provider, for extending the facility for the remote e-voting to the Shareholders of the Company.

### 4. DISPATCH OF POSTAL BALLOT NOTICE THROUGH ELECTRONIC MODE:

In compliance with the circulars issued by the Ministry of Corporate Affairs ("MCA") and SEBI, the Postal Ballot Notice was sent through electronic mode to the members whose e-mail addresses were registered with the Company/ Depositories. Pre-paid envelops were not required to be sent to the members for the Postal Ballot in accordance with the requirements as specified under the circulars of MCA. Accordingly, the assent or dissent of the Members have been casted through remote e-voting system or Physical Postal Ballot form. The Notice was also made available on the Company's website, websites of the Stock Exchanges and on the website of MUFG.

- 5. The voting rights were reckoned as on Friday, October 31, 2025, being cut-off date for the purpose of deciding the entitlements of Members at the remote e-voting and voting at the Meeting.
- 6. The e-voting period remained open from 9:00 a.m. (IST) on Saturday, November 01, 2025 and ends at 5:00 p.m. (IST) on Sunday, November 30, 2025.
- 7. The votes cast through remote e-voting were unblocked and downloaded from the e-voting website of MUFG Intime India Private Limited (MUFG) https://instavote.linkintime.co.in, in the presence of two witnesses, who are not in the employment of the Company. The e-voting data/results downloaded from the e-voting system of MUFG were scrutinized and reviewed, the votes were counted, and the results were prepared.
